**ELIGIBILITY CRITERIA**

1. This bid is open to all firms within India who are eligible to do business under relevant Indian laws as in force at the time of bidding, subject to meeting the pre-qualification criterion.
2. The Bidder should have a minimum Turnover of Rs.1.00 Crores. During the financial year 2012-13 of Assessment copies, Saral forms, PAN Card of the Bidder.
3. The Bidder should be already running a chain of Supermarkets i.e. more than 6 nos of Supermarkets in different Towns at least in Andhra Pradesh.
  - 3.1 The Bidder should be registered under Central/State – CST/TIN No, any market association recognized by the Govt. A.P., Firm registration, same evidence documents should be submitted along with the tender document.
  - 3.2 Copies of original documents defining the constitution or legal statues, place of Registration, and principal place of business of the bidding firm/entity; written Power of attorney of the signatory of the Bid to commit the Bidder.
  - 3.3 Number of employees, employed
  - 3.4 List of Present Clientele with contact address & telephone numbers
  - 3.5 The Bidder should submit the Solvency Certificate, minimum of Rs. 10 Lakhs (Rupees Ten lakhs only), issued by any nationalized Bank

The bidders must submit all relevant documentary evidence to demonstrate their eligibility for considering their bid. **The tenders received without the above documents will be rejected.**

**REQUIREMENT**

**Specifications with respect to services.**

- a. Relevant items to be sold out in the super market should be ISI/ Agmarked and Trade Marked.
- b. All daily essential commodities should be made available compulsorily.
- c. Super quality and genuine goods should be placed.
- d. Sufficient stock should be maintained invariable.
  
- e. The lessee should quote maximum percentage of discount offered by him on MRPS in respect of all packed consumer items and this should be prominently displayed in the supermarket and this discount pattern should be scrupulously followed by billing. In respect of non-packed items, the rates charged should not be more than the market rates.
- f. Service operations should be maintained properly to the customers.
- g. Organizer should maintain compliant and suggestions register for the customers appraisal on the services.
- h. The organizer and workers of the supermarket should attend quickly for suggestions and complaints.
- i. Workers should wear uniform invariably.
- j. Adequate number of automatic cash counters with bar code readers shall be maintained to avoid delay in the transaction.
- k. Stock board updated should be displayed regularly.
- l. Annual stock clearance sales and or discount sale should be declared in advance to the customers.
- m. The products should be bar-coded and billing the counter.
- n. The working hour of the maket 06.00 AM to 09.00 PM
- o. Strickly prohibited to sale of GUTKA, Tubaco, Liquer and any other items, which is injurious to health.
