#### 2. SCOPE OF WORK

Supply of 2000 Nos of Steel Cots to the RGUKT three Campuses (Located at Nuzvid in Krishna District, R K Valley in YSR Kadapa District, and Ongole in Prakasam District). The actual number of material/items to be supplied to each campus will be informed at the time of issue of purchase order.

#### 3. Tender Processing fee and EARNEST MONEY DEPOSIT / SECURITY DEPOSIT:

- 3.1 Tender Processing Fee: the tender should be accompanied by the tender processing fee of Rs. Rs.35,000/- in the form of DD (only) in the favor of the Registrar, RGUKT payable at SBI Nuzvid and EMD of Rs. 2,96,000/- by way of Demand Draft from any nationalized/ Scheduled Bank or by way of Irrevocable Bank Guarantee from any Scheduled Bank in favor of The Registrar, RGUKT along with bids. - 5.4 Bidder should furnish satisfactory Performance Certificate from the parties concerned to whom bulk supplies were made and RGUKT may contact any such parties to elicit details.

- 4. Also the bidder has to produce samples item at the time of submission of hard copy of technical bid documents. The sample will be inspected by the Members of the Committee for conformance of the specifications. The Committee may reject a bid for non-conformance of the specifications of the material. If the result of the tests indicates non- conformance, the bid will be rejected.

All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during or after completion of contract will be settled amicably in a spirit of co – operation and the RGUKT decision shall be final on all such matters and shall be binding on the Bidder. Even then, any dispute that arises will be subject to jurisdiction of the courts in Krishna district of Andhra Pradesh.



- The outer frame is of pressed steel open box type section (Profile A) of size 100 mm x 20 mm made of Electro- Galvanized (GI) sheet of 1.6 mm thick of grade confirming to IS277.
- 3. The legs are with hollow steel section of size 40 mm x 40 mm and CRC square pipe 1.6 mm thick of Yst 210 grade confirming to IS 4923

4. The intermediate supports of bed plank are of pressed steel of "U" type profile (Profile B) of size 50 mm x 35 mm made of CRC sheet of 1.2 mm thick of "grade confirming to IS 277).
